

## **Terms and Conditions**

### **(Annexure One)**

- Venture Within will organize leadership volunteer programs for you in overseas locations. While on Venture Within programs, you will be working with Venture Within, its partners, and other volunteers on humanitarian or environmental projects for village schools, orphanages, or wildlife sanctuaries in Thailand, Costa Rica, South Africa or Nicaragua.
- Venture Within will prepare and arrange accommodation for you in the location where your program is based. Venture Within will make every reasonable effort to ensure this accommodation is clean and safe.
- Upon your arrival in the country where your program is based, Venture Within will arrange necessary transport arrangements to take you from the airport to the accommodation that we have prepared and arranged for you.
- Venture Within will make every effort to ensure you will have access to three meals a day and access to clean water.
- Venture Within will provide transportation for you to and from your daily volunteer projects.
- Venture Within will organize group activities for you during your program and may include cultural activities in the evenings.
- Venture Within staff will be on site at all reasonable times throughout the duration of your volunteer program and will supervise the volunteer activities as well as facilitate the leadership development workshops.
- Venture Within desires for your efforts on the volunteer projects to have long-lasting effects and that any construction you may be involved with will carry on its purpose long after you have returned home. Venture Within will make every effort to ensure that there are experienced trades people on hand to supervise and assist you with any building projects.
- Venture Within will provide all of the materials you may need in the projects you are involved in.



### Participants' agreement with Venture Within:

- You will submit a \$500.00 non-refundable security deposit to secure your placement on a leadership volunteer program. Once Venture Within receives your security deposit and confirms that there is availability on the program of your choice, the security deposit is paid towards the total cost of the program. This is not an additional cost. Details regarding how and when you can make this payment will be provided to you.
- You will submit installments towards your Program cost as indicated in the **Participant Payment Plan (Annexure Two)** and submit the remaining balance of the total cost of your Program in accordance with the **Participant Payment Plan (Annexure Two)**. Any payment amount above the minimum required amount will be accepted between receiving your deposit and the due date of the remaining balance.
- Payments can be made directly via Venmo mobile payments to @Venture-within or [payments@venture-within.com](mailto:payments@venture-within.com) (details provided in the **Participant Payment Plan (Annexure Two)**) or via our online payment option on the “Make a Payment” page on our website: [www.venture-within.com](http://www.venture-within.com)
- You will purchase medical and travel insurance. Without providing proof of international travel insurance coverage, including full medical coverage, you will not be permitted to participate in the program. This must be purchased before your departure date. Venture Within will ask to see proof before you go, so please send us a copy of your certificate of coverage when you have purchased your insurance.
- You will follow the rules of the Venture Within program during the duration of your stay and obey the laws in the local country. Venture Within will provide you with a guideline regarding these laws during orientation on the first day of your program. This is so that the programs can run smoothly and we can better look after your safety.
- You will not carry, use, sell, or purchase any illegal substances or drugs.
- If, for whatever reason, you need to withdraw from the program at any time **within 30 days** before the date of your departure, you will forfeit the option of deferring the costs of your program towards a future Venture Within Program.
- If there is any dispute concerning any of the above issues, we will seek the appropriate authorities to resolve any disagreement between Venture Within and our participants.
